## 1 APOLOGIES FOR ABSENCE

Apologies were received from Mr S Brodie, Mr N Humphry and Councillor L Forrest.

#### 2 MINUTES OF MEETING HELD ON 25 JUNE 2001

## 3 MATTERS ARISING

- 4 Foot and Mouth Archie Kirkwood, MP, had replied to the Chairman's letter to say that the Ministers had agreed to an enquiry when the outbreak is over but not necessarily a public one.
- 5 <u>Greenrig</u> In a letter, A Isles, SBC solicitor, states that the owner is obtaining estimates for the work.
- 6 <u>Planning application, 5 The Glebe</u> refused on grounds that it would take away the straight line of the buildings. The applicant is unhappy and thinking about how he will proceed.
- 10 Scottish Borders Floral Gateway nothing heard since visit of judges.
- 13(c) Gavinton Post Office new hours of business now in force.
- 14(c) <u>Basketball net on Gavinton village green</u> this is not used partly because the base is not correct. It was suggested that it might be better in the playing field or else given to a school. Mrs Darling to ask Mary Weir and the original sub-committee to let us have their views.
- 14(d) Bridge at the Ford the handrail has been repaired.
- 14(e) Speeding through Gavinton red strips have been laid at the east and west entrances to the village. The police have no man-power to monitor speeding. Mr Brownlee, owner of the hedge and woodland which blinds the site to the bridge, pointed out in a letter that these trees are subject to the restrictions of a Woodland Grant scheme, therefore the grant would be repayable if the trees were removed. He suggested that perhaps SBC could buy the piece of land in question then negotiate with the Forestry Commission. The verge around The Old Church belongs to the owner of that property.
- 14(I) Lych gate, Fogo Church Gordon Wilson of Earlston to repair it and SBC to meet the cost.
